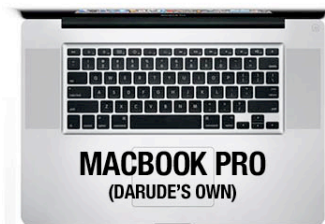

EQUIPMENT PROVISIONS

- **One (1) Pioneer DJM-900 Nexus Mixer** – **MUST HAVE latest firmware update (1.31 or higher)**

- **Two (2) Pioneer CDJ-2000 Nexus CD-Players**
- One (1) Wireless Mic. **NOT** plugged into DJM900 Nexus, plugged into in-house main mixer.
- Two (2) high quality stereo monitors for the DJ booth one (1) placed on each side of the Artist with bass & treble control, controllable from the DJM900 Nexus and a separate subwoofer.
- Table height of **at least 1,10m (3 ft 6 in)** big enough to fit controllers + laptop (diagram below).
- (1) 110-240V power outlet
- Mixer 'Master Out' switch **MUST** be set to STEREO
- Access to DJM900 Nexus 'Rec Out'
- Darude will provide the F1 and X1 controller

HOSPITALITY RIDER

Items below shall be available to Darude immediately upon arrival to the venue. **ALL** drinks shall remain **UN-OPENED**. If opened, Artist has the right to request unopened bottles as replacements.

1. One (1) Bottle Grey Goose Vodka
2. One (1) Bottle of Veuve Champagne
3. Twelve (12) Bottle of Heineken Light Beer
4. Twelve (12) Bottles of Water.
5. Four (4) Lo-Carb Monster Energy Drinks
6. Sprite, Diet Coke, Cranberry, & Club Soda
7. One (1) Box of Special K Protein Bars or Zone Protein Bars (Must be Dairy Free).
8. Three (3) Hand Towels

SOUND CHECK

- Promoter must provide the opportunity for Artist to have a 30-minute sound check prior to the show, scheduled at Artist's convenience (Time to be arranged with Tour Manager).
- Promoter will ensure that a Sound Technician will be present to assist.

DJ BOOTH

- NO ONE is permitted entry to the DJ booth without the approval of Artist or Tour Manager.
- Proper security shall be provided on stage at all times to ensure the safety of the Artist, this includes all areas of the stage, dressing rooms, and all exits/entrances that will be used by the Artist.

GUEST LIST:

- Artist shall have 15 comp VIP covers. Artist's guest list does NOT close. Guest list will be submitted to Promoter by Artist Manager or Tour Manager on the night of the show.

NOT FULFILLING THIS RIDER IS A BREACH OF CONTRACT, POTENTIALLY RESULTING IN CANCELLATION OF GIG, AND FORFEITURE OF DEPOSIT.
